# INTRODUCTION

---

The document aims to support certification bodies in determining which IFS HPC Product Scope should be selected depending on the final products manufactured by the production site. All applicable scopes should be mentioned on the IFS HPC Certificate and Report.

## IFS HPC Product Example Chart

The chart provides examples to showcase the proper allocation of IFS HPC Product Scopes. It is not meant to be exhaustive. The certification body should provide decisions for diverging allocation reasons in writing.

IFS HPC can only be applied when a product is 'processed' or when primary packing poses a hazard for product contamination. The products in the example chart are all intended for household use or personal care only.

Individual examples are assigned to the general product term within the scope, where possible.

Select the corresponding product scopes when a product is processed on-site and is intended for household use or personal care only:

Product scope 1	
Personal care products	
Bath and shower preparations	<i>Salts, foams, oils, gels, tabs, etc.</i>
Cleansing products	<i>Toner, oils, make-up remover, gel, cream, etc.</i>
Cosmetic waxes	
Cosmetic wipes	<i>Wet toilet tissues, baby wipes, pre-wetted wipes/pads, etc.</i>
Decorative cosmetic products	<i>Make-up powder, tinted foundations, highlighter, concealer, mascara, eyeshadow, make-up for children's dolls, etc.</i>
Deodorants	<i>Antiperspirants, spray, roller, sticks, creams, etc.</i>
Depilatory products	<i>Cream, wax, strips etc</i>
Emulsions	<i>Creams, lotions, milks, etc</i>
Hair care products	<i>Products for cleansing (e.g. shampoo), conditioning, styling, setting, colouring, braiding, smoothing, fixing, etc.</i>
Intimate hygiene products (external)	
Lubricating stripes of razors	
Nail products	<i>Varnish, varnish remover, etc.</i>
Oral care products	<i>Mouthwash, toothpaste, etc.</i>
Shaving products	<i>Creams, lotions, foams, etc.</i>
Skin care products	<i>Creams, lotions, oils, gels, face masks, products for after-sun, skin whitening, tanning, sun protection, lip care, etc.</i>
Soaps	<i>Bars, noodles, granules for hair, body and hand, etc.</i>
Tattoos (temporary)	
Perfume products	<i>Eau de parfum, eau de toilet, eau de cologne etc.</i>

Biocidal products	<b>Only product types 1, 2, 4, 18 and 19</b> <i>Biocidal Product Regulation (EU) No 528/2012</i>

Cleaning products	<i>Degreaser, detergents, dishwasher cleaner/tabs/ deodorants, toilet bowl cleaner, polishes, rinse aids, scratch remover, upholstery cleaner, toilet rim blocks, specific cleaners for swimming pools and cars, pre-charged foam sponges, etc.</i>

Fire lighting products	<i>Cubes, gels, liquids for barbecue and fire, etc.</i>
Insect control products	<i>Non-biocidal; Glue traps for flying insects</i>

Daily use household products	
Aluminium foil	
Baby bottles	
Cleaning cloths	<i>Cloths for floors, windows, dishes, all-purpose cloths, colour collector cloths, polishing cloths, etc.</i>
Cleaning utensils	<i>Brooms, buckets, duster pans, feather duster, mops, scourer, scouring pads (steel), toilet brushes, household sponges, mops for professional cleaning machines, etc.</i>

Clothes pegs	
Drinking bottles	<i>Plastic and stainless-steel drinking bottles, baby bottles</i>
Filters	<i>Coffee filters, tea filters, etc.</i>
Disposable table ware	<i>Cutlery, cups, etc.</i>
Household gloves	<i>(No personal protective equipment!)</i>
Ironing products	<i>Bags, fleece, etc.</i>
Kitchen utensils	<i>Plastic, silicone, stainless steel and wooden utensils e. g. chopping boards, skimmer, spatula, food storage container, straws, etc.</i>
Paper products	<i>Kitchen roll, baking paper, napkins, bags, serviettes, straws, etc.</i>

Personal hygiene products	
Absorbant pads for pets	
Bath sponges	
Cotton products	<i>Buds, pads, balls, etc.</i>
Dental utensils	<i>Dental floss, dental wood, dental plastic sticks, toothbrushes, interdental brushes, etc.</i>
Diapers	
Feminine hygiene products	<i>Tampons, sanitary pads, panty liners, menstrual cups, etc.</i>
Flannels	<i>Wash cloths, wash pads, etc.</i>
Hair care products	<i>Hairbrushes, combs, hair ties/elastics, barrets, etc.</i>
Handkerchiefs	
Manicure tools	<i>Nail clippers, scissors, nail files, tweezers, etc.</i>
Medical devices	<b>Only class I</b> such as gauze/bandages, plasters without medical impregnation, classic plasters, compresses, incontinence products
Medical / hygienic masks	<i>(No FFP masks!)</i>
Paper products	<i>Dry cosmetic tissues, tissues, napkins, toilet paper, towels in sheets, etc.</i>
